Thank you for your interest in the 2026 edition of the 29th East Mediterranean International Tourism and Travel Exhibition, EMITT.

Within the scope of EMITT 2026, in order to ensure that B2B meetings are not negatively affected and to provide a more efficient environment for both visitors and exhibitors, our exhibitors will not be allowed to organize music-themed shows or any special events within their stand areas or in the visitor corridors.

All music performances and events requested by our exhibitors may only be held on the "**Event Stage**" in Hall 1.

Our exhibitors may only organize activities such as "Press Hosting, Influencer Hosting, Talks, Gift Draws, Demo Applications, and Product Presentations" within their own stand areas each year, for their clients, the press, trade visitors, sector professionals, and buyers.

We would be pleased to support your promotional efforts by featuring these activities on our website, our social media accounts, and in the Exhibition Visitor Guide.

For the event you wish to request, you are kindly asked to carefully read the "Important Notes and Mandatory Rules" section on the last page, clearly specify all details of your planned activity on the Request Form, and tick the confirmation box at the end of the form to confirm that you will conduct the activity in accordance with the stated rules.

Important Notes and Mandatory Rules

- Music-themed shows and any special events are strictly prohibited within exhibitors' own stand areas or
 in the visitor aisles.
- Such activities may only be held on the "Event Stage" located in Hall 1.
- Forms submitted to us will be evaluated in the **order they are received**. If the preferred time slots are full, the closest available alternatives will be communicated to the exhibitor.
- No shifts or changes will be made to the event times approved by ICA Fuarcilik.
- The maximum permitted noise level is 80 dB.
- Music broadcasts must be arranged in a way that does not disturb exhibitors or visitors. Otherwise, ICA
 Fuarcilik reserves the right to intervene.
- To ensure that the maximum noise level of **80 dB** is not exceeded, **live music and the use of musical instruments (drums, zurna, clarinet, violin, etc.) will not be allowed** during events. Only **recorded music (audio tracks) played through the sound system installed for the stage** will be permitted.
- Performances must not exceed 30 minutes.
- If minors (under 18) are to participate in any event or performance, a consent form signed by their parents/guardians must be submitted to ICA Fuarcilik. To request a consent form template, please send an e-mail to neslisah.sahin@icaevents.com.tr.
- All activities and their content are subject to approval by the **ICA Fuarcilik Operations** team and the contracted occupational health and safety company, SAKA OHS.
- Submission of the form **does not imply** that the event is approved.
- Even if the event is approved before the exhibition, in case of any non-compliance identified at the venue, the **ICA Fuarcilik Operations team** and/or the contracted occupational health and safety company reserve the right to intervene.
- For health and safety reasons, the use of devices containing flammable/combustible gases, systems producing smoke, vapor, dust, or liquid, as well as balloons, blimps, drones, and smoke machines, is strictly prohibited in the exhibition area.
- Pets or similar live animals are strictly prohibited during events.
- Materials used in the event must not contradict the general appearance of the exhibition, public customs and traditions, or applicable laws and regulations; they must not contain ideological or political messages.
- Cooking inside stand areas or anywhere in the exhibition venue is strictly prohibited. Only previously cooked products may be reheated within the exhibition area.
- Exhibitors are not allowed to distribute products or hold tasting activities in the aisles.
- Exhibitors may offer product tastings only within their own stand areas and exclusively to their own guests.
- **Deadline for event request submissions**: Monday, 19 January 2026.
